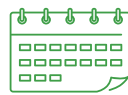

## Programme Description:

*Innovative learning and environment have all the support, social networking and flexibility.*

The Master in Public Policy at the Jeffrey Cheah Institute on Southeast Asia prepares students to develop practical solutions to real-world policy problems in the region through a multi-disciplinary focus in economics, quantitative analysis and public policy management.

This programme is formulated to equip graduates and mid-career professionals to develop greater technical capability in evidence-based policy analysis and to possess deeper understanding on fundamental concepts and contemporary issues on economic development, social inclusion, political governance and technological trends.

## Why Public Policy?

- The overlap between private and public choice and behaviour is increasing:
  - ▶ Technology and digitalisation
  - ▶ Virtual connectivity
  - ▶ Globalisation
- Pandemic shock is a good example of overlap between public and private decisions.
- Public choices are affecting our private decision to work and live:
  - ▶ Network economy:
    - C to C communication is increasing.
    - C to G communication is increasing and dictating the decisions of the government.
  - ▶ Public choices affect our livability such as climate change, aging, life-long skills development, urban poor, connectivity, wage gap between skilled and unskilled.
  - ▶ Labour mobility such as foreign workers and migration in terms to temporary and permanent.
  - ▶ We are becoming socially more rational or 'irrational' as we get more information.
  - ▶ The 'new' normal requires more digitalisation.

With the skills accumulated in this programme, graduates will be equipped to address the policy challenges of rapidly-changing socioeconomic dimensions in the region.

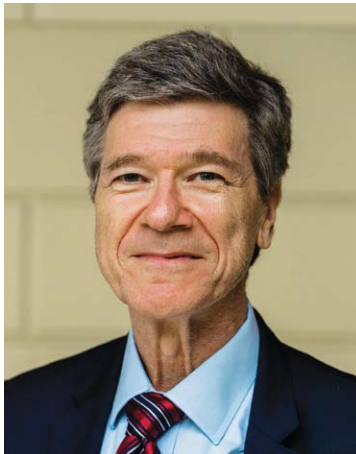

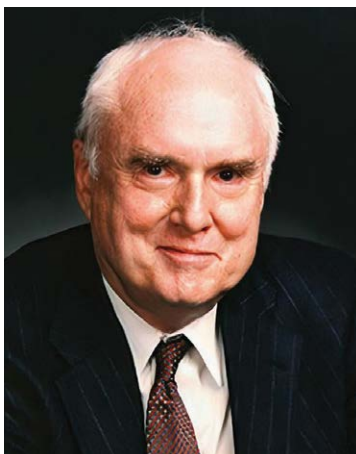
## **PROFESSOR JEFFREY D. SACHS**

*Chairman, Jeffrey Sachs Center on Sustainable Development  
Director, UN Sustainable Development Solutions Network  
Professor of Economics*

Professor Jeffrey Sachs is a University Professor and Director of the Center for Sustainable Development at Columbia University, where he directed the Earth Institute from 2002 until 2016. He is also Director of the UN Sustainable Development Solutions Network and a commissioner of the UN Broadband Commission for Development.

He has been advisor to three United Nations Secretaries-General, and currently serves as an SDG Advocate under Secretary General António Guterres. He spent over twenty years as a professor at Harvard University, where he received his B.A., M.A., and Ph.D. degrees. He has authored numerous bestseller books.

His most recent book is *Ages of Globalization: Geography, Technology, and Institutions* (2020). Sachs was twice named as Time magazine's 100 most influential world leaders, and was ranked by The Economist among the top three most influential living economists.



## **PROFESSOR DWIGHT PERKINS**

*Chairman, IAAC; Harold Hitchings Burbank;  
Professor Emeritus of Political Economy, Harvard University and Research Professor,  
Sunway University*

Professor Dwight H. Perkins is the Harold Hitchings Burbank Professor of Political Economy, Emeritus in the Faculty of Arts and Sciences. Previous positions at Harvard include Director of the Harvard University Asia Center, Associate Director of the East Asian (now Fairbank) Research Center, Chair of the Department of Economics, and Director of the Harvard Institute for International Development.

Perkins has authored, coauthored, or edited 20 books and numerous articles on economic history and economic development, with special references to the economies of East and Southeast Asia. Topics include the transition from central planning to the market, long-term agricultural development, industry policy, the underlying sources of growth in East Asia, and the role of economic and legal institutions in East Asian growth.

He has served as an advisor or consultant to the governments of Korea, China, Malaysia, Vietnam, Indonesia, and Papua New Guinea. He has also been a long-term consultant to the World Bank, the Ford Foundation, and various U.S. government agencies, including the U.S. Senate Permanent Subcommittee on Investigations. Perkins is a member of the American Philosophical Society. He received his BA from Cornell and his MA and PhD in economics from Harvard.



### **PROFESSOR TAN SRI DATO' DR. LIN SEE-YAN**

*Research Professor, Sunway University;  
Former Deputy Governor, Bank Negara Malaysia;  
President, Harvard Club Malaysia*

Tan Sri Dato' Dr. Lin See-Yan, a former banker, is a Harvard-educated economist and a British Chartered Scientist.

Prior to 1998, he was Chairman and CEO of a publicly listed commercial banking group, having previously been a central banker for 34 years. After retiring as Chairman of EXCO, Khazanah Nasional in 2000, he continues to serve the public interest, including Member, Prime Minister's Economic Council Working Group and Member, Competition Appeal Tribunal, as well as Member of some Ministry of Education Senior Committees on higher education; and Economic Advisor, Associated Chinese Chambers of Commerce and Industry of Malaysia.

In addition, he sits on the Boards of many publicly listed and private enterprises in Malaysia, Singapore, Indonesia and Thailand, engaged in mining, oil and gas, plantations, manufacturing, real estate, hospitality and entertainment, ICT, food and beverage, executive education, and power generation, as well as of universities and foundations. He served as Pro-Chancellor of Universiti Sains Malaysia (2000-2010). He is Chairman Emeritus, Harvard Graduate School Alumni Association Council at Harvard University and President, Harvard Club of Malaysia.



### **PROFESSOR DATO' DR. WOO WING THYE**

*Director, Jeffrey Sachs Center on Sustainable Development;  
President, Jeffrey Cheah Institute on Southeast Asia;  
Professor of Economics*

Professor Woo Wing Thye heads the Jeffrey Sachs Center on Sustainable Development at Sunway University. He also holds academic appointments at University of California at Davis, Columbia University, Fudan University, Chinese Academy of Social Sciences, and Penang Institute.

His current research focuses on macroeconomic management of open economies; and on the growth challenges (e.g. the middle-income trap, and the Sustainable Development Goals) of the East Asian economies, particularly, China, Indonesia and Malaysia. He has led an international team (which included Leszek Balcerowicz, Boris Fedorov, Fan Gang and Jeffrey Sachs) to study the reform experiences of centrally-planned economies; has served as a special advisor to the U.S. Treasury; and headed the project "Asia Competitiveness Report 1999" to analyse the Asian financial crisis. In 2004, the University of California at Davis awarded him its Distinguished Scholarly Public Service Award; in 2006, he was appointed a Chang Jiang Professor by the Ministry of Education of China; and in 2016, he was appointed a National Distinguished Expert under the Thousand Talents Program of China.

Professor Woo studied Economics at Swarthmore College, Yale University, and Harvard University.

## PROFESSOR LEONG CHOON HENG

*Deputy Director, Jeffrey Sachs Center on Sustainable Development;  
Professor of Sociology, Environment and Sustainability*

Professor Leong teaches in the fields of sociology, public policy, transportation and logistics. At the Jeffrey Sachs Center, his research is largely in the areas of sustainable development, community participation, sustainable transportation and education delivery systems. His earlier experience includes managing a university and heading its Transportation and Logistics Program where he taught courses related to sustainable transportation and the environment.

He has also worked on policy issues at the Institute of Strategic and International Studies, which is a policy think-tank for the Malaysian government, and as consultant to several international organizations on social development, human resource development and environmental assessment.

He holds a PhD in Sociology from Harvard University and a Bachelor of Arts degree from Colby College, USA.



## PROFESSOR DATO DR RAJAH RASIAH

*Professor of Technology and Innovation Policy,  
Faculty of Economics and Administration, University of Malaya*

Distinguished Professor Dr Rajah Rasiah is globally recognised as a pioneer in the field of innovation and development. In addition to reconceptualising technology and its measurement to reflect the reality of how innovation and spillovers occur, he pioneered the Systemic Quad model, which has revolutionised the role of strategic clustering in driving employment, wages, and sustainable development across the globe.

In addition to be a key contributor in the preparation of industrial development reports of Malaysia, and several Southeast Asian economies, he has also contributed considerably to the preparation of international development reports for the World Bank, UNIDO, UNCTAD, UNDP, UNESCO, World Intellectual Property Organisation (WIPO) and the International Labour Organisation (ILO).

He currently serves as a Distinguished Professor of International Development at the Asia-Europe Institute, University of Malaya.



### PROFESSOR JAMES CHIN

*Director, Governance Studies Programme Jeffrey Cheah Institute on Southeast Asia*

Professor James Chin is a Senior Fellow and the Director of Governance Studies at the Jeffrey Cheah Institute on Southeast Asia at Sunway University. He is also the inaugural Director of the Asia Institute, University of Tasmania. He is a leading commentator on Malaysian politics and has published extensively on Malaysia and the surrounding region. He was previously Senior Visiting Research Fellow, Institute of South East Asian Studies (ISEAS), Singapore; and Professor of Political Science, Monash University, Malaysia campus. Prior to an academic career, he worked as a journalist in Malaysia and Singapore.

His most recent publication are; Malaysia Post Mahathir: A Decade of Change? (2015); 50 Years of Malaysia: Federalism Revisited (2014) and Awakening: The Abdullah Badawi Years in Malaysia (2013). Prof Chin has published extensively in leading journals such as Asian Survey, Journal of Contemporary Asia, Asian Journal of Political Science, Commonwealth and Comparative Politics, The Round Table, Southeast Asian Affairs, Asian Politics & Policy, Journal of Democracy, Electoral Studies, Democratization and South East Asia Research.

He has also written commentaries for leading publications such as The New York Times, The Diplomat, Australian Outlook, The Conversation, The Straits Times, East Asia Forum and New Mandala.



### PROFESSOR SHANDRE MUGAN THANGAVELU

*Professor of Development Economics and Green Technologies,  
Jeffrey Sachs Center on Sustainable Development  
Vice President, Jeffrey Cheah Institute on Southeast Asia*

Professor Shandre is an active researcher on human capital development, technology transfer, foreign direct investment, trade, government infrastructure investment, productivity and economic growth; and has published extensively on these topics.

Apart from his position at Sunway University, he is also Regional Director (Southeast Asia) at the Center for International Economic Studies, Institute of International Trade, University of Adelaide; as well as the Director of the Asia Growth Research Center, University of Adelaide.

He was appointed Fellow of the Economic Research Institute for ASEAN and East Asia (ERIA) in 2017. He has also worked on several international projects commissioned by UNDP, World Bank, ASEAN Secretariat, APEC, and Asian Productivity Organization (APO). His graduate degrees are from Queen's University, Canada

## PROFESSOR WONG CHIN HUAT

*Professor, Governance Studies Division, Jeffrey Cheah Institute on Southeast Asia;  
Professor, Jeffrey Sachs Center on Sustainable Development*

Professor Wong is a political scientist at both Jeffrey Sachs Center on Sustainable Development (JSC) and Jeffrey Cheah Institute on Southeast Asia (JCI) at Sunway University.

Trained as a comparativist in University of Essex, UK, he specialises in electoral system and party system. A long-term advocate for electoral reform in Malaysia through the civil society-based Coalition for Clean and Fair Elections (Bersih), he now leads the clusters on electoral system and constituency delimitation in the Malaysian Government's Electoral Reform Committee (ERC). Beyond political institutions, Wong also studies identity politics and leads an annual survey on Malay-Muslims in Malaysia, Nadi Melayu-Muslim, funded by Germany's Friedrich Ebert Stiftung (FES).

Wong's political insights are featured in international and domestic media in English, Chinese and Malay, including New York Times, Project Syndicate, Aljazeera, Malaysiakini, Astro and The Initium (Hong Kong). He has also published books on Malaysian politics in English and Chinese.



## DR CHEN JIT ERN

*Research Fellow, Jeffrey Sachs Center on Sustainable Development;  
President, Jeffrey Cheah Institute on Southeast Asia;  
Senior Lecturer in Biological Sciences, Sunway University*

Dr Chen Jit Ern completed his PhD at the University of Cambridge working on identifying genes involved in lipid biosynthesis in microalgae for biofuel production.

His work in Sunway University is focused on studying the possibility of inducing experimental evolution in Symbiodinium in order to develop more heat-tolerant strains that may be more resilient to heat-driven mass coral bleaching events caused by climate change.

Prior to joining Sunway, he was a Post-Doctoral Fellow in KAUST, Saudi Arabia, working on the genetic manipulation of the coral endosymbiont Symbiodinium. Dr Chen received his B.A. (Hons) in Natural Sciences and his Ph.D. from the University of Cambridge.

## POSTGRADUATE PROGRAMMES BY RESEARCH

### ELIGIBILITY CRITERIA

Scholarships are open to all **full time postgraduate** students enrolled for programmes **by research**. Eligibility criteria are given in the table below. Additionally, applicants must meet all necessary entry requirements for their chosen programme of study and be in receipt of an unconditional offer from the University.

Awards made to students under this scheme shall take effect from the 1<sup>st</sup> day of enrolment and shall, subject to satisfactory performance and successful progression, last for the normal duration of the programme. The University reserves the right to withdraw the award at any time should the student's behaviour or performance be unsatisfactory, or the student withdraws or is withdrawn from the postgraduate study.

The student must have successfully completed their proposal defense, have received ethics approval and be able to demonstrate that data collection has commenced by the end of Year 1 to continue the scholarship funding for Year 2.
